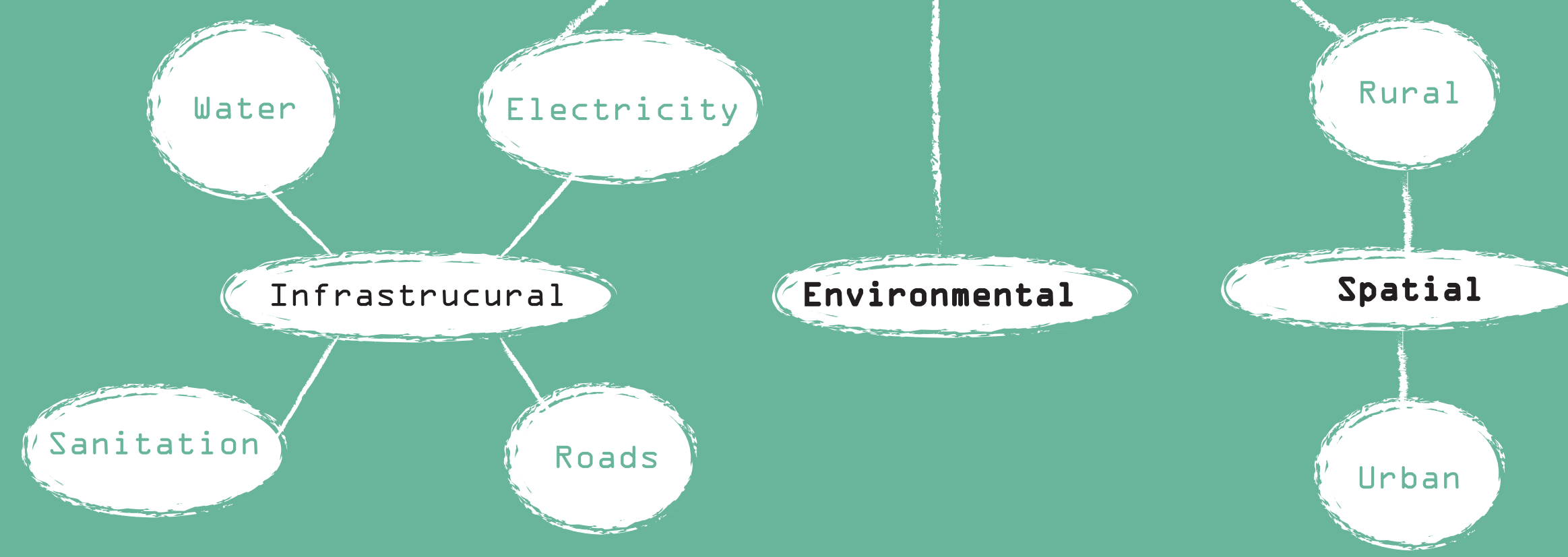


PHYSICAL CONTEXT:

 - Rural development prioritization plan.

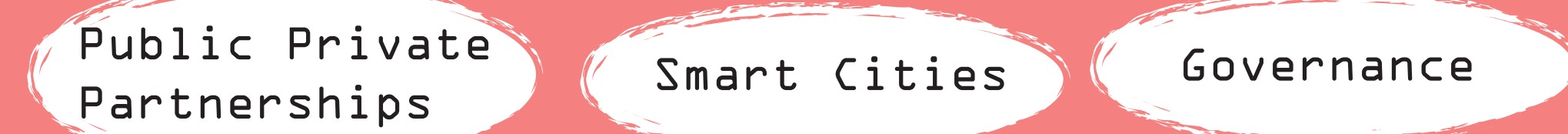
Year 5-10:

Year 10-15:

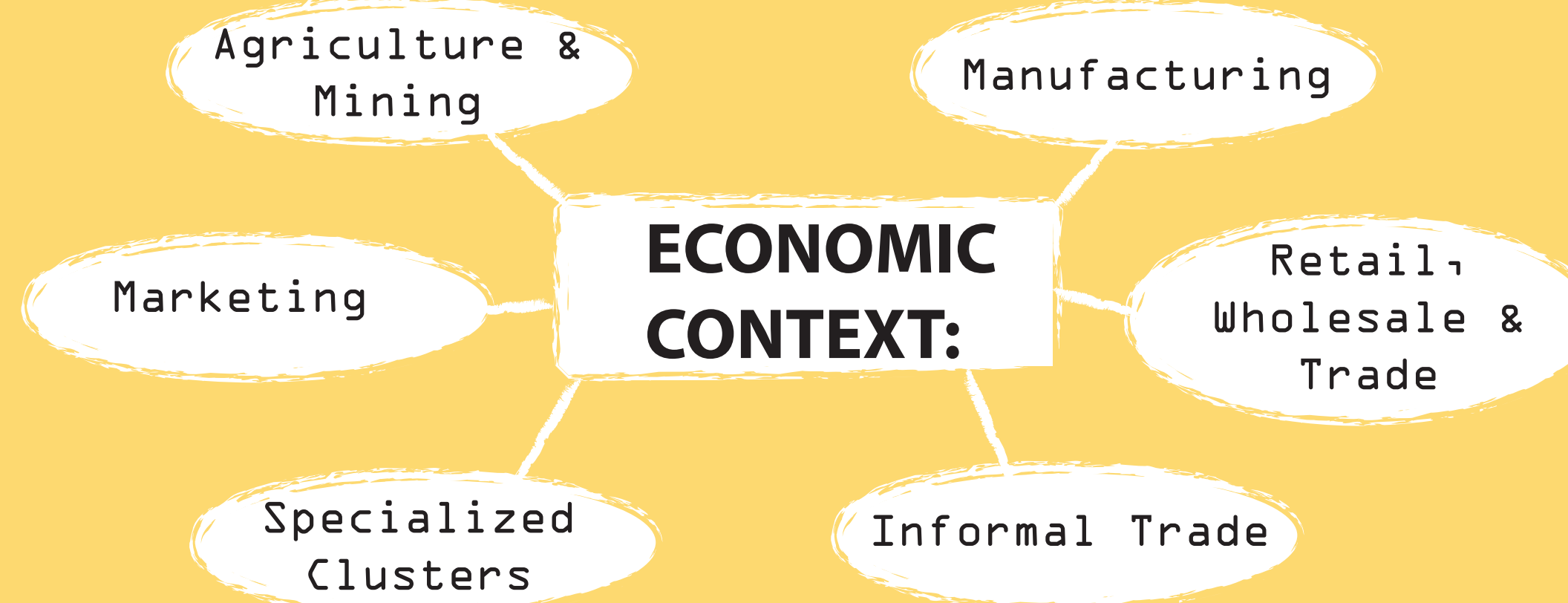
- Digital information displays throughout city.

ECONOMIC CONTEXT:



Municipal Outcome(s):

- i.) Increased economic growth, job creation and sustainable human settlements.
 ii.) Improved Efficiency and Effectiveness of Municipal Administration.

Objective(s):

- Bridge gap between subsistence and commercial farming.
- Utilization of strategic location for manufacturing and logistics.
 - Alternative retail platforms.
- Tolerance and support towards informal sector.

Intervention(s):

Year 1-5:

- Specialized clustering plan development.
- Locate strategic informal trading areas as part of the urban redevelopment strategies.
 - Establishment of an online market space

Year 5-10:

- Establishment of Special Economic Zones for the proposed clusters.
- Development of the Polokwane Informal Trade Policy

Year 10-15:

- Implementation of clustering strategy.
- Formal establishment of areas for commonage farming, supporting uses and infrastructure.

SOCIAL CONTEXT:



Municipal Outcome(s):

- i.) Increased economic growth, job creation and sustainable human settlements.
 ii.) Improve community confidence in the system of local governance.

Objective(s):

- Creation of an environment in which there is sufficient stimulation for the youth to develop and prosper.
 - Promotion of women's rights.
- Educated population with regards to health and wellness.
 - Major improvements in Early Childhood Development

Intervention(s):

Year 1-5:

- Provision of safe parks and recreational areas where the youth can practise sports.
- Campaigns targeted specifically at women in rural areas to inform them of their rights and recourses.
 - Development of a schools nutritional programme.

Year 5-10:

- PPP's with telecommunications companies for the supply of ICT infrastructure at youth centres
- Development of women and child care facilities.

Year 10-15:

- Decentralised ECD training and education.
